Subject: Revision in the rates of laying of HDPE pipes by HDD method for estimation purpose.

The rates for laying of HDPE pipes by HDD method were circulated vide Circular (corrigendum) No.DJB/RA/EE(PLG)W-II/2016/C-4/14631 A dated 20.06.2016. Till date, the estimates were scrutinized, accordingly.

It has been decided by the competent authority that the rates of laying of pipes by HDD method as published by Indian Society for Trenchless Technology (ISTT) may be considered for estimation purpose only for different diameters as per site conditions and requirement. However, justification for the item will be prepared on market rates (minimum three quotations basis). The latest rates as published by the ISTT in the year 2020-21 are enclosed herewith.

The above rates will be applicable till the time the rates are revised by the Consultant and approved by the competent authority. The scope of work for the Consultant to be appointed by EE(P)SR-I under CE(DR)PR-III for revision in the rates for Trench-less item will be extended to include revision in the rates of laying of pipes by HDD method also.

Subject: Revision of Rates of Micro-tunnelling Works for estimation purpose.

The rates for laying of pipes by micro-tunnelling work for 600 mm dia and above were circulated vide Circular (corrigendum) No.DJB/RA/EE(PLG)W-II/2016/C-4/14631A dated 20.06.2016. Till date, the estimates were scrutinized, accordingly.

Now, it has been decided by the competent authority that the rates for laying of pipes of 600 mm dia and above by micro-tunnelling method as published by the Indian Society for Trench-less Technology (ISTT) may be adopted in Delhi Jal Board for estimation purpose only. However, justification will be prepared as per market rates. The latest rates as published by the ISTT in the year 2021 are enclosed herewith.

Further, a Consultant will be appointed by EE(Plg)Water-II to revise the SOR rates for Trench-less Items. The above rates will be applicable till the time the rates are revised by the Consultant and approved by the competent authority.


